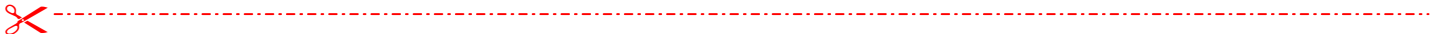

**Dana Point Fine Arts Association (DPFAA) Application and Show Rules**

- Participants must be **a current member** in good standing of the DPFAA.
  - Each artist must have a valid California State Board of Equalization Seller's Permit.
  - Artwork must be created by the participant. Reproductions must be marked as such. Crafts, jewelry, clothing, et.al., are not allowed.
  - *Space Assignments & Show set-up rules* will be sent the week prior to show.
  - Artists will be charged 10% commission on all sales made. The funds will be collected at the end of the last day you are showing by the Show Chairperson.
  - Should the event be rained out, a refund of the entry fee will be made.
  - The Show Chairperson and Board have final authority for decisions on the selection of show participants, space assignments, and resolutions of show-related conflicts or issues.
- **Application Deadline Date:** **Saturday, Oct. 7.** Show Chairperson can accept late applications, depending on space available. Contact the Show Person directly.
  - **Refund Deadline Date:** No refunds will be made after **Monday, October 9.** If there is a need to cancel your participation in the show, contact the Show Chairperson.
  - **Space Fees:** **\$20** per day

  - **Enclose:** **Application (FILLED OUT COMPLETELY) and a check (made payable to DPFAA) for space fee.** Participating artists will receive their space assignment, set-up rules, map, and instructions through **email** prior to the show.
